## Agency Update

#### Child Welfare 101

DSS staff present were: Jennifer Morgan, Child Welfare Program Administrator, Becky Burleson, formerly known as Foster Care now is Permanency Planning Supervisor; Sherry Miller, In-Home Services Supervisor; Jenny Milsaps, Foster Home Licensing; formerly known as Foster Care; Sara Brewer, Permanency Planning Supervisor; Carla Reid, Investigator -Assessments; Brandon Gaddy, Intake

The first presentation was on Child Protective Services (CPS). There is currently an average of 70 reports per month, and most calls come in during the school year.

Also covered in the presentation was Assessments with CPS, In Home Services; Permanency Planning; and Foster Home Licensing program. There are currently 34 licensed foster families and 109 children in foster care.
