McDowell County (Owner) is requesting Bids for the construction of the following Project:

Modification for Muddy Creek Watershed Structure No. 16

Bids for the construction of the Project will be received at the McDowell County Purchasing Office located at 25 West Fort Street, Marion, North Carolina 28752, until Friday, July 29th at 2:00 PM EST local time. At that time the Bids received will be publicly opened and read.

The Project includes the following Work:

McDowell County is accepting bids for the modification of Muddy Creek watershed structure No. 16 in McDowell County. The modification to dam No. 16 of the Muddy Creek Watershed in McDowell County, NC consists of the replacement of the existing trash rack with a newly designed trash rack. The modified trash rack has been designed to alleviate problems associated with clogging of the existing trash rack and dam riser structure. The modified trash rack is composed of a 42" half-round corrugated metal pipe. The pipe will be capped at the top and bottom and have perforations ranging from 3.5" to 6.5" in diameter along the length of the pipe. A 2.5' wide rectangular opening will also be included approximately 0.5' from the top of the pipe. In addition to the modified trash rack, a 30" Waterman C-20 or approved equal canal gate assembly will be installed to replace the missing gate assembly. A ladder will also be installed on both sides of the perforated pipe to aid in maintenance activities. Bids are requested for the following Contract: **Modification of Muddy Creek Watershed Structure No.**
