SPECIFICATIONS:

- A. The Portable Restroom Trailer will meet DOT regulations to be driven on the Highway.
- B. The Portable Restroom Trailer will be 27' in length
- C. The Restroom Trailer will have three sections (1) Men's section (1) Women's section and (1) ADA compliant section. Each section must be labeled Men's or Women's on the outside.
- D. The Men's section will have (1) Toilet (2) Urinals and (1) Sink.
- E. The Women's section will have (3) Toilet's and (1) Sink.
- F. The ADA compliant section will have (1) Toilet and (1) Sink.
- G. The Portable Restroom Trailer will hold a minimum of 225 gallons of fresh water.
- H. The Portable Restroom Trailer will hold a minimum of 600 gallons of waste.

- M. The Portable Restroom Trailer will have a (5)-year limited trailer manufacturer warranty on the trailer frame and axles and a (2)-year limited warranty on the trailer as a whole. Sealant, electrical components, hydraulics, hoses, wall coverings, trim and paint should be warranted for 1 year, and 1-3 year warranty on Individual appliances.
- N. The Portable Restroom Trailer will be equipped with a 4 season heat package.



Further Instructions to Bidders:

Bid Deposit. A Bid Deposit must accompany each bid.
